1. Apologies

2. Minutes of meeting held on 18 November 2021

6. Proposal to Derestrict the Hampshire Memorial Fund

There had been some discussion amongst the committee about making the remainder of the funds raised for the HMS Hampshire memorial to be released into general funds. The editor of the volume on the loss of the Hampshire was agreeable, so long as a note was kept of how much money sales of the volume continued to generate. There was however an issue with releasing these ringfenced funds, as the Society's membership must be fully consulted before anything can go ahead, and this will take some time. The AGM was not therefore able to sanction this request. This will be annotated further to the membership, probably in the next newsletter and will return to the 2023 AGM.

7. Election of Charity Trustees

As Vice-President, Sheena Wenham briefly took the floor to nominate the committee en masse, which was unanimously agreed by all present. Two new members of the committee were nominated, Lynn Campbell nominated Andrew Lind, seconded by John White. Spencer Rosie nominated Julie Gibson, nominated by Tom Rendall.
